Tyla Yaweh Firefly Festival Sweepstakes Official Rules

The "Tyla Yaweh Firefly Festival Sweepstakes" (the "Sweepstakes") may only be entered by legal residents of the forty eight (48) Contiguous United States and the District of Columbia, excluding Hawaii, Alaska, territories and possessions ("Sweepstakes Territory").
